



CPEC Members Club Covid-19 Operation & Safety Plan

Please ensure you have read this in advance of Dressage Night. The Plan must be read and agreed to by everyone who intends to enter Dressage Night.

Due to the COVID-19 restriction, only authorised people will be allowed onto the grounds. We are very sorry but due to the restrictions we must apply additional entry conditions as follows:

- You must be a rider, parent, carer, groom or support person to enter the grounds.
- No spectators are permitted.
- Please limit the number of people attending with you to no more than 1 per rider if at all possible and for everyone's benefit.

With the government restrictions that are in place, CPEC Members Club appreciates your cooperation and understanding at this time.

Overview

Please ensure you (and anyone joining you : Parent or Carer – STRICTLY NO SPECTATORS ALLOWED) read and comply with this plan in advance of your attendance on 18th September 2020 for your own safety and the safety others.

Non-compliance with this plan by CPEC Members Club members or those accompanying them may lead to the associated member's membership to be revoked.

All members and those attending with them are required to take personal responsibility for their own health, safety and wellbeing.

Parents and instructors, please ensure any children under 18 years of age have read this plan and explain to them in advance of Dressage Night. Please ensure they understand that they must comply with this plan.

Covid-19 Symptoms – Feeling Unwell

You are NOT permitted to attend Dressage Night if you have ANY of the following symptoms:

- Loss of taste/smell;
- Flu-like symptoms;
- Fever;
- Cough;
- Sore throat;

- Fatigue; and
- Shortness of breath.

You are not permitted to attend to Jump Night if you have :

- Been to any Covid-19 hot spots (as outlined by NSW Health) within the last 14 days; Please refer the NSW Health website for Covid-19 hot spots update.
- Been in contact with a person who test positive for Covid-19 in the last 14 days;
- Returned from overseas in the last 14 days; and/or
- Travelled to or returned from Victoria in the last 14 days.

If you become unwell during Dressage Night you MUST report your symptoms to the Covid-19 Officer and will be asked to leave the grounds. NSW Health advises any with the mildest symptoms to get tested ASAP.

Should someone become unwell during or after Dressage Night and later tests positive for Covid-19, they must notify CPEC Members Club on 0406 280 546.

Check in and Covid-19 Self Declaration Form

Everyone (participant and person accompanying the participant) attending Dressage Night is required to check in with the Covid-19 officer at the Main Arena.

A temperature check for all participants, accompanying parties, parents, volunteers will be performed at check in. Any person with temperature of 37.4 degrees Celsius or more will be asked to leave the area immediately and seek a Covid-19 Test.

All persons working/participating/volunteering) will be required to complete the CPEC Members Covid-19 Self Declaration Form, any parents who attend will sign the Site Attendance Register. These documents will be supplied at the registration check in desk and the Self Declaration form will be emailed to relevant persons.

Physical Distancing

1.5m physical distancing is to be maintained at all times. No visitors are permitted unless parents.

Throughout the event all persons will be required whether mounted or unmounted to maintain physical distancing requirements unless members of the same household.

Where persons are mounted on horses there is likely to be a natural degree of physical separation. Venue is responsible for overall maximum capacity of site.
